Valspar offer the ability to order Valspar paint colour chips online via Valsparpaint.co.uk ("Offer") in addition to the ability to pick up Valspar paint colour chips from the chip rack inside B&Q stores. Valspar paint is exclusively available at B&Q stores ("Stores").

The Offer is subject to the following terms and conditions ("T&C's"):

- 1) The Offer is valid from 27.07.2020
- 2) Valspar paint colour chips are small painted cards which match to the two thousand (2000) pre-selected colours shown on instore chip rack in B&Q, and the pre-selected colours section of the Valsparpaint.co.uk website ("Valspar Colour Chip(s)"). The Valspar Colours Chips are only available in the two thousand (2000) pre-selected colours.
- 3) Valspar Colour Chips are not available for any colour matched colours and the colour matching service is only available in Stores.
- 4) The Offer allows consumers to order up to ten (10) Valspar Colour Chips free of charge per order ("Order"). There is a limit of five (5) orders per person every six (6) months.
